Year 8 EOTC Activities
Tuesday 15th February 2022

Christchurch South's Year 8 Outdoor EOTC activities are taking place in Term 1 this year, with a focus on team-building and personal development. This is a one-day excursion.

We will be going to Stoddart Park, Diamond Harbour for Coasteering & Raft Building/Canoeing & Jetty Jumping in the morning, then to Orton Bradley for High Ropes and a Bush walk in the afternoon.

Transport to and from the venues will be by bus, and emergency vehicles will be taken courtesy of parent helpers.

Along with reconnecting with classmates, the aims of the outdoor experience include:

- becoming active, skilled and safe in the outdoors
- developing further group cohesion
- fostering personal and social development through a range of adventurous as well as low-risk activities

Instructors from Adventure Specialities Trust will be facilitating these activities and are fully trained and experienced. They will also receive support from CSKI staff and parents when working with our students.

The cost of the outdoor activity is \$137.50. This includes transport, activity instruction and any other associated costs. The outdoor activities can only happen if the associated costs are covered. We have appreciated parents meeting these costs in the past and hope it continues in the future. Therefore, if you haven't already made the suggested contribution of \$137.50 to cover the costs we ask that you urgently consider this.

Students need to be at school at 7.45am on the morning they leave for their outdoor activity. Buses leave at 8.00am. Students will return from their activity at approximately 4.30pm.

More details regarding the gear list required will be sent out in the following weeks – please look out for this important information so your child is fully equipped for the day.
